Dear Daniel Rogers (in your capacity as the Director of CSIS),

CC: Other relevant organizations and parties

I write you today about a matter of national security. I have irrefutable evidence of the existence of an extremely well-organized international terror group operating in Canada which has yet to be acknowledged by CSIS or by any national security group to my knowledge, apart from the United Nations Office of the High Commissioner for Human Rights.

The appropriate due diligence I expect in response to this letter includes the following actions which I await:

- 1. Provide official confirmation that this group is known to exist, that its activities constitute *terrorist activity* according to the definitions in the *Criminal Code section* **83.01** (1), and that the national security and intelligence community is committed to preventing this group from carrying out any more attacks against CSIS, preventing the continued infiltration into legitimate government and social infrastructure, and preventing the genocide of vulnerable minorities such as neurodiverse peoples like myself.
- 2. I need to be properly and fully debriefed regarding all knowledge I possess about this group. This includes but is not limited to the personal information I possess about multiple murders, attempted murders, organized harassment operations, corruption of lawyers, judges, doctors, politician's office staff, public safety officials and infiltration into other groups, especially those that are involved with the most vulnerable, marginalized people, such as homeless shelters, outreach groups, mental health support services, and more.

Please consider this letter to be a formal complaint for the purpose of escalating the matter to NSIRA, should I fail to receive a response, or should the response fail to meet the criteria described above.

I will hereafter provide a brief summary of the chronology of events which led to my conclusion that this group exists, and to the conclusion that it is a bona fide terror group according to the legal definition.

2007-2008: Various individuals were found to be stealing my personal information, including but not limited to theft of registered postal mail

2009 March: A professional hit man and his accomplice attempted to murder me in cold blood near the Halifax Casino.

There was no known reason for this attack at the time. It was clearly a carefully premeditated and organized attempted murder. The hit man (a very spry individual in his 30s) failed to knock me down by striking me with a weapon on the back of my neck, but drew blood which gushed profusely down my back. The hit man fled and his elderly accomplice attended the scene shortly thereafter to lie to police, claiming that he was the one who had been involved in the altercation and he also lied by alleging the reason for me bleeding from the back of my head was because I fell and hit my head.

Rather than getting justice for this attempted murder, I was arrested without explanation and the perpetrators were set free to carry out more murders.

2011-09-30: Michael Lamoureux gave me a beverage of unknown composition at 5212 Sackville Street in Halifax. I walked home and sat on my bed to meditate. Without any apparent time passing I was suddenly in the hospital ICU.

My first memory after sitting on my bed is when I pulled a breathing tube out of my throat. I noticed that I was hooked to machines and devices which were keeping me alive. I could see that I had severe injuries including broken bones and lacerations. I had no knowledge of how I arrived there or how I was transported out of my bed. I later learned that nearly two days had lapsed without any memory of the events.

Rather than getting justice for having been nearly murdered for the second time, I was arrested and wrongfully accused of involvement in an apparent car crash which had nearly killed me.

I later discovered that while unconscious, my roommate Jonas and other unknown accomplices put my unconscious body into my vehicle. They drove to a pharmacy where they obtained 250ml of hand sanitizer and injected the sanitizer into my rectum. They put blue metal cylinders which had been stolen from the Halifax property seizure room into the vehicle. They then crashed the

vehicle into a taxi which was carrying Ward Robinson who may or may not have been deceased after an altercation at the Halifax Casino.

Greg Dunbar, an off-duty paramedic was the first on scene and helped the driver of the vehicle I was in to escape the wreckage. Dunbar was unable to remove my body from the wreckage because I was pinned into the centre console after the contents of the vehicle were flung toward the driver's side. The driver of the vehicle I was a passenger in fled the scene. After Dunbar finished attending to my injuries, he could not find the driver of the vehicle anywhere and he inquired with Caitlin Perry as to where the driver had absconded to. Perry did not know, as she was too upset to understand or pay attention to what was happening.

Constable Robert Tortola then arrived on scene after these significant events had already unfolded. He would later lie under oath and claim to be the first on scene.

All relevant evidence and witnesses were suppressed by judicial officials, and perjured testimony was substituted in its place. I was denied the right to test the blood sample to determine what I had been drugged with and to prove that I had been unconscious at the time of the crash. I was denied access to counsel despite my disability which professional medical evidence now clearly states it is "imperative" that I have counsel to represent and support me. My motion to appoint amicus curiae was denied. In other words, no defence counsel, nor any legitimate, independent or objective lawyer was allowed into the courtroom during the scandalous miscarriage of justice.

2017-07-17: Professional hit man and gang member Janson Baker finally attempted to murder me, long after I had been explicitly told that he was there to kill me months earlier. I had been accumulating names and information about staff members who had been involved in setting up this murder. This information was stored on the monitored computer systems. One of the key individuals in the plot was Sean MacLeod, who was later assassinated in the worst mass shooting in Canadian history.

I sustained serious injuries from the assault by Baker, including broken bones, severed nerves and a severed artery. A guard attended the hospital where I was transported after the attack and told me that she had witnessed the entire incident. Despite this, Baker was never charged for the attack and was released where he committed the murders of two confidential RCMP informants whose identities had been protected by security classifications.

2019 October – December: I was released to Parrtown CCC where Parole Officer Helene St-Onge convinced me to sign over permission to access the medical documentation about my autism spectrum disability. This documentation included a list of vulnerabilities which would purportedly result in extreme distress and potential bodily harm to myself or others. These vulnerabilities include such things as interacting with me using certain demeanors, certain strong odors, sudden unexpected changes in my living arrangements, and other vulnerabilities. The very

next business day after St-Onge received this medical document I was unexpectedly arrested by police for an alleged breach of parole which was never fully explained.

Up until 2020 I had no evidence to suggest that any of these activities were being carried out by a terror group of any kind. It appeared to be a series of unfortunate incidents by individual bad actors, criminals, and isolated corrupt officials.

2020:

Within a month or two after the medical information was received by St-Onge, suddenly literally hundreds of random people began to do all the things which were listed in that medical document as being things which would result in severe distress or harm. The people carrying out these activities were both staff and offenders. This shift was sudden and dramatic and unmistakeable.

The fortunate thing is that all the vulnerabilities which were described in the medical document were generic vulnerabilities which are experienced by many autistic people, but none of them cause me any distress of any kind. This fact enabled me to carefully catalog and assess the behaviours I was observing without any distractions.

My initial theory about what group might be facilitating the organized harassment was that it might be CSIS. The reason, in part, that I suspected CSIS was because Helene St-Onge told me she knew people in CSIS and could set up a meeting. This suggested to me that she might have provided the medical document to CSIS. I theorized that what I was observing was clearly a covert operation (psyop) which was being carried out against me. It was being done inside a federally controlled institution. It was also taking place outside the institution on domestic soil. I theorized that CSIS was now allowed to carry out these types of activities after Bill C-51 gave them new "kinetic powers" in 2015. Some of the individuals who were proximal to these operations were making overtures about being involved with the intelligence community. I therefore made accusations directly to CSIS asserting that they were carrying out these terrorist activities against me. I received no denial of any kind until my second formal complaint to the director of CSIS which was escalated to NSIRA.

During my online research regarding the organized harassment operations I was witnessing, I encountered a massive propaganda machine, akin to the kind described in Mein Kampf. I also located a document on the website of the United Nations Office of the High Commissioner for Human Rights, which described very precisely the activities I was observing.

This document is as follows:

Harassment techniques include:

1. Surveillance (being followed, electronic surveillance, computer and phone hacking, monitoring all online activities, and bugging of home)

- 2. Profiles are built to identify any and all weaknesses and insecurities to be used later. Information often obtained through sexual partners or trusted people in their lives.
- 3. Conditioning where victims are sensitised to certain stimuli such as everywhere you go someone will cough as they walk past you. The goal is to make you self police and then think anyone who coughs is involved in the harassment. People report of conditioning to include hand gestures, an overt use of colour in peoples clothing (like everyone you see wearing red) or cars a certain colour or with headlights on (also known as brighting).
- 4. Anchoring where someone will provide false rationales for the harassment. Often many possible rationales are planted to keep the victim confused and the focus of the harassment cycles from one possible reason to another round and around so as to keep the victim guessing in a self perpetuating guessing game where every scenario you are to blame and causes self doubt, fear, intimidation, and ultimately a cycle of destructive thoughts
- 5. Mobbing (or true gangstalking) where everywhere you go you will see an overt display of people following you and often use words you have been conditioned to or your name to draw your attention
- 6. Street theatre where a group will "perform" an overt activity like a fake confrontation or scenarios designed to test your reactions. Often takes the form of a couple who position themselves near you and then have a conversation using many of your conditioned words or pertaining to your particular situation and sensitivities.
- 7. The use of directional speakers which have the ability to direct sound to a single individual in a crowded room. This particular item is ultimately the most used and is often referred to as V2K or Voice to Skull and is used extensively in the psychological breakdown of the victim. The use initially is to cause the victim to doubt their sanity and drive them into the mental health system, and later to just torment and never give the victim a moment of privacy or peace. If they do enter the mental health system, then harassment escalates dramatically as the victim has now been "discredited" and can be labeled as someone with a mental problem if they do speak out about the harassment.
- 8. The use of electronics to effect your eyesight and balance which was originally developed for the military and police crowd control called "dazzling" and even the ability to make you vomit.
- 9. Sound campaigns which is a community harassment technique where abnormal levels of sound are directed at the victim and their home. This includes cars deliberately breaking or accelerating when they pass, people talking excessively loudly at all hours of the night, amplification of sound using directional speakers so that external sounds that previously couldnt be heard now can, garbage trucks and other heavy vehicles, and countless other deliberate tactics
- 10. Sleep deprivation this is perhaps one of the most insidious tactics used where victims are woken multiple times a night and can be kept awake for days at a time. The effects are dramatic and completely debilitating effecting concentration, mood, irritability, appearance, and significantly impacts all areas of their life job performance, relationships, and significantly aids in discrediting the victim as they appear unorganised, disheveled, and sleeping patterns alter so they may sleep during the day (where noise campaigns are more effective) and be awake at night (where they can be painted as the one making noise and being a disruptive member of the community).
- 11. Baiting or entrapment where victims are harassed to the point that they lash out and commit a crime such as assault, break and enter or vandalism, as they try and locate the source

of the harassment. Harassers will actively try to provoke verbal and physical confrontations especially after a period of sleep deprivation. Or they are prompted into an activity which can then be used as leverage such as affairs, sexuality, drug use, or other criminal activity.

12. Gaslighting which is a form of psychological abuse where someone will actively try undermine victims and to make them doubt themselves so that they lose all self confidence and self esteem and are therefor easier to manipulate and push toward the mental health pathway. It can be as simlpe as being told something which they then deny, then telling them how silly they are for thinking they said it, and turn the lie around into an attack on the person.

13. Blackbag jobs is a term when a harasser breaks into a victims property and places something or deliberately moves something. The purpose is to cause self doubt, and fear that their property is being accessed which harassers try to then sell as paranoia.

It can be incredibly effective coming from a trusted person and before the victim understands

what is happening to them.

- 14. Propaganda and disinformation is also the other key element to suppress knowledge of this practice as its effectiveness initially requires the victim to be unaware of the existence of gangstalking, gaslighting, or the electronic technologies such as directional speakers so huge amounts of time are devoted online to creating disinformation sites which attempt to discredit victims by pushing the mental health agenda. They achieve this by posing as victims and actively trying to sound crazy so that all victims are are treated as such. Also by creating websites claiming to help victims and being a resource for victims to come together and then harassing them to the extent that they lose hope and no longer reach out for help causing further isolation.
- 15. Further to the above, gangstalkers rely on disbelief and discrediting and as such much of the harassment is designed (at least initially) to mimic mental health issues. They also rely on their abuse being so extreme, so pervasive, so fundamentally immoral, as to be disbelieved and victims subsequently resort to photographing, videotaping, and sound recording their everyday encounters to disprove the countless unfounded claims made against them especially in relation to gaslighting, which gangstalkers try to turn around and paint the victims as paranoid or irrational. Victims are made to feel helpless as every attempt to defend themselves is used against them and when they seek help they are met with disbelief or open hostility.

I traveled all across Canada, from Newfoundland to BC and confirmed that everywhere I went, I encountered literally hundreds of people who were carrying out these activities precisely as described in the UN document.

My investigations into the social infrastructure across Canada turned up countless disturbing infiltrations by the terror group into service providers for vulnerable people, such as homeless shelters, outreach groups, Meetup groups, online dating, medical clinics, mental health organizations, nonprofits and more.

2024-05-30: I received an official response from NSIRA explicitly stating "the Review Agency determined that the allegations raised in your complaint do not refer to an activity carried out by CSIS."

After receiving this official denial of involvement in the activities, I accepted this as fact. I then began to reassess my theory about what group might be responsible.

During the reassessment, it occurred to me that a key part of the organized harassment involved attempts to radicalize me against CSIS, which ultimately led up to explicit attempts to provide me with firearms at 35 West Hastings Street in Vancouver.

A cursory review of auxiliary information suggests that this attempted radicalization was not an isolated incident, and is being carried out globally, aiming to weaponize victims of organized harassment against the Five Eyes. If CSIS prioritizes its people as their new slogan suggests, they need to take this information very seriously.

2024-06-01 – **Present:** The organized harassment continued for a time, and I continued collecting evidence of the criminal and terrorist aspects of the harassment operation. My reassessment of the group which was responsible for the terrorist activities included various online and offline investigation and counterintelligence. My personal observations and evidence I have collected about the organized harassment are consistent with the description of "harassment techniques" found in the United Nations document.

Today:

I have completed an assessment of the types of tactics being deployed, the various levels of awareness and persuasions of the participants and victims, the apparent reactivity to certain comments, accusations, and other investigatory tactics.

The aggregate analysis has led me to the current working conclusion that the people responsible for these activities comprise a globally connected hierarchically organized group. The ideology which appears to motivate the activities is substantially similar to the original Nazi ideology. The methodology appears to be consistent with known tactics of Nazi groups and other ideologically motivated hate groups.

Infrastructural blitzkrieg is carried out against the heads of key organizations. The targets are controlled using a combination of bribery, manipulation, intimidation, psychological operations, gathering of "dirt" using illegal spying and home invasion, entrapment by luring the target into an illegal scheme, making examples such as the murders of Bernard and Rose-Marie Saulnier, wrongful imprisonment and assassination as was carried out and attempted against myself, and other terrorist tactics.

The organizational quid pro quo, in efforts to avoid paper trails often relies upon the concept of an "old boys club" where illegal or corrupt favors are traded and expected in return.

To disrupt this terror network a combination of tactics has proven effective. Counterpropaganda, in the form of informing the participants that they are participating in a genocidal neo-Nazi scheme directed against vulnerable minorities such as neurodiverse peoples, MMIW, non-Aryan races is effective. The similarities to the original Nazi T4 program are alarming. Also, it is necessary to disrupt the ability of participants to make good on their corrupt promises. I have done both so far by surviving multiple assassination attempts and by informing nearly everyone I have identified as a probable collaborator about the similarities to Nazi ideology, terrorism and genocide.

The results of my efforts are readily observable and very substantial, especially considering I am just one person. It should be easy to scale these efforts up to be deployed by professional agencies, as long as the heads of those agencies are "untouchable", so to speak.

Conclusion

This matter demands immediate attention and action at the highest level. The organized terrorism campaigns I have detailed here are not isolated nor trivial—they represent a serious threat to national security, human rights, and the rule of law. I urge you to treat this situation with the urgency, integrity, and seriousness it requires, ensuring prompt collaboration and thorough investigation.

Given that the heads of key organizations are being targeted for control by corruption or undue influence, it would be wise to suspect that this is the case inside the intelligence and military establishments, and to direct initial investigations accordingly. Resistance to confronting this terror group or to validating the loyalties of security officials should be interpreted as a strong warning signal that whoever is presenting this resistance is likely either a direct collaborator or might be a compromised pawn of the terror group, either knowingly or unknowingly.
